# **Additional Service Charges**

Next Business Energy's Additional Service Charges apply to services that are provided associated with your electricity supply but are outside of the tariff charge for the supply of electricity. These maybe for services provided by us, your distributor, or your meter service provider. These charges are usually passed through to you at cost.

#### **Retail Service Charges**

Next Business Energy will charge an additional fee to cover the cost of credit card surcharges and declined payment fees.

Dishonoured Payment Fee - We may apply a dishonour fee to cover our administrative and processing costs, where insufficient funds are not available in your nominated payment method when processed. You may also be charged similar fees by your financial institution or payment service provider.

Late Payment Fee – As our Terms and Conditions outline, Next Business Energy may apply a late payment fee if an invoice is not paid in full by

Payment Investigation Fee – As outlined in our Terms and Conditions where we are required to investigate a payment on behalf of you and/ or your bank, we may apply a Payment Investigation Fee where it is determined that the payment was valid.

# **Meter Service Charges**

Next Business Energy will charge an additional fee to cover the additional costs of advanced metering provided by a Meter Provider on a per meter basis.

This charge will be applied Monthly and is based on the meter types installed. If you don't know what type of meter you have, call us on 1300 GO NEXT to ask us to confirm your meter type and applicable cost.

Next Business Energy will charge a DMA service fee per NMI per day for each NMI listed in a Direct Metering Agreement where we are charged for DMA activities. These charges will be listed separately on your electricity invoice.
